# PPIC Statewide Survey mission

- Provide timely, relevant, nonpartisan data on political, social, and economic opinions
- Inform and improve state policymaking, raise awareness, encourage discussion
- Provide a voice for all Californians in important state policy debates
  - 318,000+ Californians since 1998
  - 150+ general, issue, and regional surveys


# Californians and Their Government

- General series funded by The James Irvine Foundation
- State election policy landscape
  - Approval ratings and overall mood
  - Economic inequality, Proposition 30, climate change, health care, and 2016 ballot issues
- Federal election policy landscape
  - Approval ratings, congressional elections, and presidential candidates
  - Party favorability, party preferences on issues, voting, and reforms
- Telephone interviews, November 8–17
  - 60% landline, 40% cell phone
  - 1,703 adults,  $\pm 3.7\%$  margin of error
  - 1,115 likely voters,  $\pm 4.4\%$  margin of error




# Most important issue today

Thinking about the state as a whole, what do you think is the most important issue facing people in California today?




# Outlook for the state

Do you think things in California are generally going in the right direction or the wrong direction?




Turning to economic conditions in California, do you think that during the next 12 months we will have good times financially or bad times?


# Income inequality in California

Do you think that California is divided into haves and have-nots, or do you think that California is not divided that way?




# Are you in the haves or have-nots?

If you had to choose, which of these groups are you in—the haves or have-nots?




# Perception of state budget situation

Do you think the state budget situation in California—that is, the balance between government spending and revenues—is a big problem, somewhat of a problem, or not a problem for the people of California today?




# Extension of Proposition 30 taxes

In your view, is global climate change a very serious problem, somewhat serious, not too serious or not a problem?




# Effect of state efforts to reduce global warming on jobs




# Medical coverage for undocumented immigrants

Do you favor or oppose providing health care coverage for undocumented immigrants in California?




# Special interests and the initiative process






# Satisfaction with choice of presidential candidates

In general, would you say you are satisfied or not satisfied with your choices of candidates in the election for U.S. president in 2016?




# Preference for presidential candidate with experience or new ideas

Which of the following is more important to you in a presidential candidate—experience and a proven record new ideas and a different approach?




# 2016 Congressional elections

What is your preference for the outcome of next year's congressional elections: a Congress controlled by Republicans or a Congress controlled by Democrats?









# Automatic voter registration

# Conclusions — California's 2016 Election Landscape

- Majority approval ratings for President Obama and Governor Brown are limiting support for political outsiders and setting tone for 2016 election
- Water and the economy are top state issues; mixed results on state's current direction and next year's economic outlook
- Many say state school bond and minimum wage increases are very important ballot items
- Public support for health reform and climate change, but partisan divide exists
- Party preferences and impressions highlight the role of changing demographics
- New and proposed reforms could increase voter rolls and turnout over time
