**Roanna Bennie** is interim president of Las Positas College in Livermore, California. Since she became interim president in 2017, she has focused on leading the campus facilities planning for the large Measure A bond, increasing campus security measures, and integrating state initiatives into the campus. Previously, she served as the college's vice president of academic affairs. Before moving to Las Positas, she was vice president of instruction at Miramar College in San Diego. She also served as an academic dean at Cuesta College and Allan Hancock College, and as the chief instructional officer for Life Pacific College—a private, independent school. She has been a member of several boards and professional organizations, including the Association of California Community College Administrators (ACCCA) and the Community College League of California (CCLC).
