Angela Avery leads the Sierra Nevada Conservancy by providing strategic direction and oversight to the agency's region-wide staff. As executive officer, she is committed to restoring the health and resilience of the Sierra Nevada region. He currently serves as chair of the California Board of Forestry and Fire Protection. Under his leadership, the board has engaged in substantive revisions to the portions of the California Public Regulatory Code dealing with protection of watercourses, fire safety-related land use planning, and non-industrial forest management plans, as well as crafting emergency rules to allow the public to deal with problems such as tree mortality resulting from drought and fire. He previously served on the USDA's Forest Research Advisory Council. He holds a joint PhD in forestry and agricultural economics from the University of Wisconsin—Madison.

Henry McCann is a research associate at the <u>PPIC Water Policy Center</u>, where he manages research projects and provides core research support. His recent projects have focused on water information and accounting systems, urban drought resilience, and headwater forest management. He previously managed research projects within the Smart Water Systems initiative at the UCLA Luskin Center for Innovation. He holds an MA in urban and regional planning from the University of California, Los Angeles.

Jeffrey Mount is a senior fellow at the <u>PPIC Water Policy Center</u>.
