Mia Bird is a research fellow in corrections and health and human services at PPIC. She also serves on the faculty of the Goldman School of Public Policy at the University of California, Berkeley. At PPIC, she co-leads a collaborative project between the California Board of State and Community Corrections (BSCC), PPIC, and several partner counties, known as the BSCC–PPIC Multi-County Study. This effort is designed to estimate the effects of realignment on recidivism outcomes and identify best practices for recidivism reduction at the local level. She also leads a project focused on the impact of the Affordable Care Act on enrollment and recidivism outcomes for the criminal justice population. She holds a PhD in public policy, an MA in demography, and an MPP from the University of California, Berkeley.
